Admission Policy

1. Our policy

The Graduate School of Global Environmental Studies seeks to secure the current and future health and sustainability of the global environment in two essential ways: first, by training future researchers and practitioners for future environmental careers in academia, management, policy-making, advocacy and project implementation; and second, by establishing sustainability as the basis of an integrated and interdisciplinary field informed by ethics, science, technology and the humanities that can address the environmental challenges confronting the 21st century.

2. Who are we looking for?

Our goal is to produce graduates who through their excellence and distinctive talents will have an impact in their chosen fields. We are seeking students who demonstrate high moral character and richness of spirit, including:

- Future researchers from all academic fields with a keen interest in global environmental problems and their solutions.
- Future internationally-minded practitioners with a deep enthusiasm for environmental management and a sincere commitment to acquiring and implementing the knowledge and practical skills required to tackle environmental problems from the local to the global level in every walk of life. Our body of students is diverse, coming from many different backgrounds and possessing many different perspectives. Our students enter through a variety of admission tracks, including a mid-career admissions option for students with extensive work experience in environmental issues, some of whom may choose to study while continuing their professional careers, and an international admissions program for international students.

3. What are we looking for?

The Graduate School of Global Environmental Studies offers master and doctoral programs in the field of environmental management, as well as a doctoral program in global environmental studies. The admission requirements for each of these programs relates to the objective of the study program provided.

3.1 Global environmental studies

Our three-year doctoral program in global environmental studies aims to foster researchers who are capable of grasping the full complexity and reach of global environmental issues and tackling global and local environmental issues with an innovative mindset and a range of methodologies that are drawn from a wide variety of scholarly fields, as well as practitioners who have such academic quality. Applicants to this program should hold a master's degree in their chosen field of study in addition to English language proficiency and a keen interest in global environmental issues, but exemptions may be made for those with demonstrated professional experience and expertise in a field related to their expected area of study.

3.2 Environmental management

Our two-year master's program and three-year doctoral program in environmental management are designed to foster outstanding and internationally-minded practitioners who are capable of applying management skills in the search for practical and sustainable solutions to local and global environmental problems, as well as researchers who have such practical capabilities. Applicants to either of these programs will need basic academic knowledge of global environmental issues and English language proficiency in addition to a keen interest in environmental management.

4. Basic policy on admissions

The admissions process for the master's program will be carried out by means of a comprehensive assessment of documents, foreign language ability, and an interview. The admissions process for the doctoral program will be carried out by means of a comprehensive assessment of documents and foreign language ability as well as a research presentation and interview.

The Graduate School of Global Environmental Studies (GSGES), Kyoto University, invites international students to apply for three-year doctoral programs in Global Environmental Studies and Environmental Management through a special admission process called the International Environmental Management Program (IEMP), which is an English-taught degree program.

All applicants for this examination must understand the following:

- This examination is for international students with superior academic records, wishing to apply for the MEXT Special Scholarship Program.
- All applicants are required to select an academic supervisor from the list of eligible faculty members on page 7.
- Applicants **must** contact their intended faculty member (on page 7) **prior to** application in order to request future supervision for their chosen study program and advice for the application process.


1. Eligibility Requirements and Screening

1-1. General eligibility requirements

1-1-1. General eligibility requirements

Applicants must satisfy all the following requirements.

- 1) You must have completed or intend to complete a master's degree or its equivalent by **September 30, 2026.**
- 2) You must not be a Japanese national.
- 3) You must be applying for MEXT Special Scholarship described in section 1-1-2 below.



1-1-2. Eligibility requirements for MEXT Special Scholarship Program

A few applicants who pass the IEMP admission process will be qualified for the final selection of the MEXT scholarship. Applicants will receive the results of the selection in July, 2026*.
*The schedule may be subject to change.

Scholarship duration

Up to three years

Scholarship coverage

- 1) Monthly stipend of approximately 145,000 yen
- 2) Economy class travel expenses to and from Japan (Airfare for return travel will be provided only after successful completion of the study program.)
- 3) Admission and tuition fees

Eligibility requirements for the MEXT scholarships in GSGES applicants

1) Nationality

Applicants must be from a country which has diplomatic relations with the Japanese government.

2) Visa and study experience in Japan

Applicants must newly obtain a student visa* at the Japanese diplomatic mission located in their country of nationality and enter Japan with the resident status of "student". If applicants have experience of studying at any Japanese universities as a recipient of MEXT Scholarship, they must have at least three years of academic or work experience after the end of the scholarship period.

* Those living in Japan at the time of application are also eligible, but applicants living overseas may be preferentially nominated.

3) Age

Born on or after April 2, 1991

4) GPA

Applicants must have a GPA of 2.30 or higher. The GPA must be calculated by the designated way by MEXT. Refer to the Calculation Sheet on pages 11 and 12.

5) Current status

Applicants must not be active members of the military.

6) Other scholarships

Applicants who are expected to receive a scholarship or fellowships from Japanese government, a Japanese government-related organization and others will not be accepted as a grantee of MEXT Scholarship.

7) Duplication of applications

Applicants must not apply for a MEXT Scholarship through any other graduate schools or universities

Before sending the request to the recommender through the system, you should contact them by email (or any other communication tool) to make sure the recommenders understand your request. Your application will not be completed on the system without uploading letters of recommendation. Letter A) Should be written by an academic supervisor (or its equivalent) of your current or most recent study program. A designated form will be automatically attached to the request to the recommender on the system.

4. Admission Selection

Admission selection will be carried out by means of a comprehensive evaluation of the documents, English ability and online interview.

4-1. English Score

To evaluate English ability, <u>all applicants including native speakers of English</u> must upload **one** of the following:

- 1) Score record of **TOEFL-iBT** (recommended; including TOEFL iBT Home Edition),
- 2) Official score certificate of **TOEIC Listening & Reading** (Secure/Public testing program), or
- 3) Test report form of IELTS (Academic Module).

If you do not upload one of the above, you will be graded "zero" for English ability.

IMPORTANT: In each case, the score record submitted should be for a test-score dated on or after April 1, 2022. Original official score reports sent directly to Kyoto University by ETS (Educational Testing Service) will not be accepted. The score records of TOEFL-CBT, TOEFL-ITP, TOEIC Bridge, TOEIC-IP and IELTS (General Training Module) are not acceptable.

Note: Applicants may find the following information useful, if they have several test scores and wish to identify the most suitable for submission:

- A TOEIC score can be converted using the score comparison table on page 10.
- Conversions of IELTS scores into TOEFL scores can be made using the 'TOEFL iBT and IELTS Academic Module Scores Comparison Tables' provided by ETS.

4-2. Interview

Online interviews will be held in accordance with the following:

Date & Time	Contents
February 2, 2026 9:00 -18:00 (JST) * The date and time of the interview for each applicant will be specified from the above period. (Applicants cannot specify the interview date or time.) * The interview session is approximately 50 minutes long.	Specialized knowledge gained through your master's study or practical experience; contents of your proposed research plan presentation; any relevant knowledge about the research plan or related subjects.

(1) Evaluation criteria for the interviews:

Your research ability, significance of your proposed research, presentation effectiveness and the contents of application documents.

(2) Grading criteria:

All applicants will be graded according to the sum total of marks (500 points maximum) for English ability (100 points maximum) and interview performance (400 points maximum). The interview assessment includes a review of your proposed research. In order to pass, an applicant's combined marks must total at least 300 points, comprising at least 240 points out of the 400-point total for the interview.

- (3) You should prepare Microsoft PowerPoint slides for the interview.
 - You will be given approximately 20 minutes for the presentation. Detailed instructions about the submission of presentation files will be given on January 27, 2026.
 - Note that the submission period will be quite short. Please prepare slides in advance.
- Before taking the interview, ensure that you will be in an appropriate environment (e.g., a quiet and private room) with a stable internet connection and the necessary equipment (including camera, speaker, microphone). For further details, refer to the attachment "Guidelines for taking the online interview".
- The examination voucher can be downloaded on the Online Application System from January 27 onward.
- Detailed instructions on the interview, including dates and times, will be emailed on January 27.

5. Announcement of Examination Results

The result will become available on Online Application System at 10 am on February 13, 2026.

- *We do not respond to any phone calls or other inquiries regarding examination results.

6. Admission and Tuition Fees

Instructions regarding enrollment procedures and payment of admission/tuition fees will be sent to successful applicants by email in late August, 2026. Admitted students must obtain their college student visas by the enrollment date. The nominee for the MEXT Special Scholarship will be required to submit extra documents before enrollment procedure. For details of student visa and documents for MEXT scholarship, check "Notification for successful applicants" which will be available on the examination result page of Online Application System.

Admission fee: 282,000 JPY

Tuition fee: 267,900 JPY per semester (535,800 JPY annually)

Not required for those expected to graduate from a master's program or a professional degree program at Kyoto University in the previous month of the enrollment date, recipients of MEXT Scholarships.

Not required for the recipients of MEXT Scholarships.

Guidelines for taking the online interview

Please read and confirm the following items carefully that concern taking the online interview.

What to do by the day of the interview:

- 1. Ensure that you are in an appropriate environment (e.g. a quiet and private room) when taking the interview.
- 2. Check in advance whether the interview can be conducted stably with the necessary equipment (including camera, speaker microphone) and whether the internet connection is suitable. Be sure to update your OS and Zoom application and check your connection status, microphone, speaker, and camera settings.
- 3. If taking an interview from overseas and it is difficult to satisfy the above 1 or 2 items, be sure to notify the GSGES administration office at the time of application for examination through online application system.

What to do on the day of the interview:

- 1. Have your examination voucher handy.
- 2. Access the Zoom link specified in the examination guidelines 15 minutes before the interview time.
- 3. Set the display name on Zoom to your Applicant ID and name. (e.g. 1001: GSGES)
- 4. Follow the instructions given by the staff. Sit directly in front of the camera, showing your facing and upper body (do not wear a mask) so that we can verify your identity. During the interview, keep your upper body about 1m away from the camera so that it fits in the video frame. Do not use virtual backgrounds.
- 5. When prompted by the staff, show the entire surroundings of the room with your web camera used for the interview.
- 6. When prompted by the staff, use Zoom's screen sharing function to demonstrate that no apps or tabs other than Zoom are running on your device.

- 7. Be sure to remain visible in the camera during the entire interview.
- 8. Do not keep anything near you other than the examination voucher and the electronic equipment used for the interview.

About cheating

The following acts may be regarded as cheating and should be avoided.

- · Being in an environment where background noise such as telephones interfere with the interview
- Being in the company of a third party during the interview
- Communicating with a third party regarding the interview questions
- Recording the interview video or audio
- Entering and leaving the room during the interview
- Carrying out actions that give the impression of having in hand other items except for the examination voucher and the computer equipment used
- Acts of using the computer equipment for purposes other than the communication about the questions asked (e.g. looking up information online)
- Leaking the contents of questions to other parties
- Committing other acts that impair the fairness of the test (e.g. reading reference materials, intentionally interrupting the internet connection, etc.)

Troubleshooting on the day

- If it is difficult to conduct the interview on the scheduled day due to an Internet connection failure, etc., the interview may be conducted on another day and time during the examination period. Details will be announced later.
